Treating each child with respect and dignity and adjusting the curriculum to meet their individual concerns, interests, handicaps, special talents, and individual style and pace of learning. Be thoughtful for each child's relationship to his or her cultural and socioeconomic background.
- 7. Assist in the planning and implementation of a curriculum for the assigned classroom in accordance with the policies and philosophy of Little Flower. Ensure open communication with Teachers and Assistant Teachers assigned to your room by effectively and timely communicating curriculum plans.
- 8. Responsible for assisting in the overall appearance and decor of the classroom assigned. Assist with doing and managing the housekeeping responsibilities of the classroom.
